1	The total number of sections of Bal vatika shall be restricted to 03(one sections each in Bal Vatika I,II & III respectively). The total number of sections in the school from class I to X shall be restricted to 10. The optimum number of students shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye-laws and availability of class rooms of greater than 500 sq.fts dimension.
2	The school is not running bal-vatika. Thus, it is required to submit an undertaking on its letterhead that it will run bal-vatika in the upcoming session within 03 months in the compliance.
